LATEST ADVICE AND MEASURES IN BRITISH COLUMBIA

- The BC Government has issued two emergency orders that temporarily suspend in-person
 execution requirements for wills and personal planning instruments, including representation
 agreements and enduring powers of attorney.⁴ The emergency orders are tied to the provincial
 state of emergency and will expire when it is lifted.
- Today Dr. Bonnie Henry, in line with advice from the federal government, encouraged the use
 of non-medical masks or cloth face coverings in public settings.⁵
- Dr. Bonnie Henry also encouraged people to complete the provincewide Your story, our future survey (http://www.bccdc.ca/health-info/diseases-conditions/covid-19/covid-19-survey) to share personal experiences with COVID-19 so far. To date, 286,000 British Columbians have already completed the survey.⁶
- The BCCDC reported today that:⁷
 - Most regions have reported very few cases, deaths and hospitalisations in recent days.
 - The number of cases in the pediatric population remains low, only 3 have required hospitalisation and none have died.
 - The number of cases in hospital continues to decrease; the number of cases in critical care has been stable for about a week.
- As of yesterday, many businesses may reopen as British Columbia has entered Phase 2 of its Restart Plan.⁸

LATEST ADVICE AND MEASURES IN YUKON TERRITORY

- Today the Government of Yukon announced an extension of the Yukon Business Relief Program to July 23, 2020.⁹
 - The Yukon Business Relief Program helps Yukon businesses that have experienced a 30 per cent reduction in revenue due to COVID-19 and need immediate support to cover fixed costs, including rent, utilities and business insurance.
 - Eligible businesses can apply for a grant of up to \$30,000 per month to cover fixed costs.
- As of May 15, 2020, the Territory is in Phase 1 of the Government of Yukon's reopening plan, A Path Forward.¹⁰

LATEST ADVICE AND MEASURES FROM THE GOVERNMENT OF CANADA

- Today, Canada's Chief Public Health Officer, Dr. Theresa Tam, recommended that Canadians wear non-medical face masks when physical distancing is difficult to maintain.¹¹
 - The recommendation was issued on behalf of Canada's Special Advisory Committee on COVID-19.
 - The Special Advisory Committee posted updated advice online today (http://www.phn-rsp.ca/sac-covid-ccs/wearing-masks-community-eng.php), explaining that masks can serve as a supplementary measure to existing public health recommendations such as physical distancing and regular handwashing.
 - Dr. Theresa Tam noted during her announcement that the recommendation isn't mandatory and allows for public health officers across Canada to consider their area's needs.
- The Prime Minister announced that application documents and updated criteria for Canada Emergency Commercial Rent Assistance (CECRA) for small businesses are now available.¹²
 - This program will provide forgivable loans to eligible commercial property owners to:
 - reduce the rent owed by their impacted small business tenants
 - meet operating expenses on commercial properties

- The property owners must, in turn, offer a minimum 75% rent reduction for April and May (retroactive), and June, to their small business tenants.
- Applications will be accepted through the Canada Mortgage and Housing Corporation website (https://www.cmhc-schl.gc.ca/en/finance-and-investing/covid19-cecra-small-business) beginning on May 25, and application documents can be accessed now.
- The Finance Minister and Minister of Innovation, Science and Industry, today announced the opening of the application process for the government's Large Employer Emergency Financing Facility (LEEFF).¹³
 - The Canada Development Investment Corporation (CDEV) has formed a new subsidiary, Canada Enterprise Emergency Funding Corporation (CEEFC), to administer the LEEFF.
