LATEST ADVICE AND MEASURES IN BRITISH COLUMBIA

- Today, Dr. Bonnie Henry and Adrian Dix released the following joint statement regarding updates on COVID-19:5
 - "As we get back to work and back to school this fall, it is the time for all of us to cut back on our social interactions to reduce the risk of contracting COVID-19 for ourselves and everyone around us."
 - "Keeping our household contacts and our controlled work and school groups safe means having few contacts with people we don't know."
 - "We need to ensure our public health teams are able to take care of everyone in British Columbia in the weeks and months ahead. As a result, the provincial health officer's order on bars, nightclubs and banquet halls has been amended. Effective today, all nightclubs and stand-alone banquet halls are ordered closed until further notice."
 - "Liquor sales in all bars, pubs and restaurants must cease at 10 p.m. and they must close at 11 p.m., unless providing a full meal service, in which case they may stay open, but may not serve liquor until 11 a.m. the following day."
 - "Music or other background sounds, such as from televisions in bars, lounges, pubs and restaurants, must be no louder than the volume of normal conversation."

LATEST ADVICE AND MEASURES FROM THE GOVERNMENT OF CANADA

- Today, Dr. Theresa Tam, Canada's Chief Public Health Officer, provided the following remarks on COVID-19 in Canada:⁶
 - "Schools, classrooms and shared spaces will look fundamentally different and teaching methods will vary. Many children will welcome the return to school, routines and classmates, but others will find the numerous changes more difficult. We can help children transition by listening to their concerns and by being honest about our own."

- "Although Canada is striving to maintain a "slow burn", the average daily case count
 has been increasing in recent days. This is concerning. And I want to underscore that
 when cases occur, including in schools, it is a reflection of what is happening in the
 community."
- "The key to keeping COVID-19 at a manageable level is for each and every one of us to keep up effective public health practices at home, at work and in the public spaces we frequent."
- "I would like to take a moment to say a few words to parents, caregivers and guardians. You are doing your very best you can right now and there is no "one-size fits all" approach to a child's learning. Decisions are not made lightly. So, to all of us....kind words, encouragement, and letting a parent in your life know that you are there for them can be a lifeline."
- "There are also mental health resources for parents and children on Canada.ca and there are other mental health resources including the Kids Help Phone, Families Canada, and Crisis Services Canada that provide invaluable support."
- Today, the Minister of Justice and Attorney General of Canada, David Lametti, announced funding to Egale Canada to help respond to the increased demand for legal information for LGBTQ2 Canadians who have been disproportionately affected by the COVID-19 pandemic.⁷
 - Egale Canada is developing webinars in both official languages to help meet the needs
 of LGBTQ2 individuals with intersecting, racialized identities who are experiencing
 unique and exacerbated access to justice challenges related to housing, employment
 and immigration during the COVID-19 pandemic.
 - The Department of Justice is providing \$125,784 to Egale Canada through the Justice Partnership and Innovation Program.
- Today, Deputy Prime Minister and Minister of Finance, Chrystia Freeland, and the Minister of Small Business, Export Promotion and International Trade, Mary Ng, announced that the Canada Emergency Commercial Rent Assistance (CECRA) will be extended by one month to help eligible small businesses pay rent for September.⁸
 - Current CECRA application deadlines will also be extended to accommodate this
 extension. This will be the final extension of this program as the government explores
 options to support small businesses as they face the ongoing challenges of the COVID19 pandemic.
 - Participation in the one-month extension is voluntary. Both existing applicants to the CECRA and new applicants are able to opt for the September rent reduction.
 - Details on the September extension will be available on the CMHC website on Wednesday September 9.
